MINUTES OF THE SECOND MEETING OF NATIONAL COMMISSION FOR SCHEDULED CASTES HELD ON 04.08.2014 AT 1.00 PM

Third Meeting of the National Commission for Scheduled Castes (NCSC) was held on 04.08.2014 under the Chairmanship of Dr. P. L. Punia, Hon'ble Chairman, NCSC. List of participants is at **Annexure 1**.

Agenda Item No. 1: Confirmation of minutes of the Second meeting of the Commission held on 03.03.2014.

Minutes of the Second meeting of the Commission were approved unanimously.

Agenda Item No.2: Action Taken Notes on the minutes of the 2nd meeting of the Commission.

Action Taken: Action Taken Reports were noted by the Commission with the observation on CMIS- that many defects have been identified with the consultation of the respective Sections/Units of the NCSC Hqrs. Hence it was decided that DG, NIC and Senior Officers of the NIC & Ministry of SJ&E may be called in the NCSC to resolve the problems for making necessary corrections in the CMIS Software to make it properly functional. **(Action: Admn.)**

Agenda Item No. 3: Inclusion of Sarathi, Soot Sarthi, Sahis, Sais and Thanwar Castes and Synonyms of Ghasi, Ghasia, a Scheduled Castes at Sl.No.25 of the list of Scheduled Castes of Chhattisgarh.

Action Taken: The NCSC concurred the proposal of the State Government of Chhattisgarh for inclusion of Sarathi, Soot Sarthi, Sahis, Sais and Thanwar Castes and Synonyms of Ghasi, Ghasia, a Scheduled Castes at Sl.No.25 of the list of Scheduled Castes of Chhattisgarh. The Ministry of SJ&E may be informed accordingly. **(Action: SSW)**

Agenda Item No. 4: Inclusion of Peruvannan as synonym of Mannan, Pathiyan, Perumannan, Vannan, Vela (Sl.No.37) in the list of Scheduled Castes in the list of Kerala.

Action Taken: The NCSC concurred the proposal of the State Government of Kerala for inclusion of Peruvannan as synonym of Mannan, Pathiyan, Perumannan, Vannan, Vela (Sl.No.37) in the list of Scheduled Castes in the list of Kerala. The Ministry of SJ&E may be informed accordingly. **(Action: SSW)**

Agenda Item No. 5: Proposal for replacement of the existing entry "Malayan (in the areas Comprising the Malabar District) by "Malayan

(in the areas comprising Kozhikode, Wayanad and Kasaragod)" in the list of Scheduled Castes of Kerala.

Action Taken: The NCSC concurred the proposal of the State Government of Kerala for replacement of the existing entry "Malayan (in the areas comprising the Malabar District) by "Malayan (in the areas comprising Kozhikode, Wayanad and Kasaragod)" in the list of Scheduled Castes of Kerala. The Ministry of SJ&E may be informed accordingly. **(Action: SSW)**

Agenda Item No.6: Information/data on representation of SCs in Group 'A', 'B', 'C' & 'D' posts under State/UTs Govt. Services.

Action Taken: The matter was considered and it was decided that the State-wise data may be compiled on the following items:-

- (a) Representation of SCs in Group 'A', 'B', 'C' & 'D' posts.
- (b) On the State SCSP schemes for the year 2012-13.
- (c) On Atrocities

This data may be provided to the Hon'ble Chairman, Hon'ble Vice-Chairman and Hon'ble Members for ready reference and copies kept with Sections/Wings & Incharges i.e. Consultant, Director, Under Secretaries and Deputy Director.

All the data so collected and compiled may be included as part of Annual Report. **(Action: SSW)**

Agenda Item No.7: Orders of the Hon'ble High Court of Delhi & Allahabad in WP© No.2390 of 2012 & WP© No.28072 of 2014 respectively wherein the order of NCSC passed in the representations of Shri Anil Kumar Akarnia and Shri Karan Pal Singh have been quashed and the proceedings of NCSC have been stayed.

Action Taken: (a) The Commission has decided to file a review petition in WP© No. 2390/2012 filed before the Hon'ble High Court of Delhi in the matter of Union of India and others Vs. NCSCs in the case of quashing the orders of NCSCs passed in representation of Shri Anil Kumar Akarnia. This is in view of the facts that NCSC was not served notice in the case and hence no Counter Affidavit was filed on behalf of NCSC. Since, NCSC has not passed any orders on the representation of Shri Anil Kumar Akarnia but has merely made a recommendation which is in line with the mandate of the NCSC, the same should be brought out in front of the Hon'ble Court. **(Action: SSW)**

(b) In WP(C) No. 28072 of 2014 filed before Hon'ble High Court of Allahabad in the matter of Municipal Corporation of Ghaziabad Vs. NCSC in the case of Shri Karan Pal Singh, Zila Adhyakash, Bharat Shoshit Morcha, 1/A, GDA Building, 1st Floor, Old Bus Stand Compound, Ghaziabad, UP regarding illegal demotion of

Budh Vatika Building/structure, discussion was held on the order of Hon'ble High Court staying the proceedings of the Commission. The Commission has decided to file the counter affidavit and hiring of own lawyer so that the case maybe effectively pursued in the Hon'ble Court. **(Action: ESDW)**

Any other item with the permission of the chair: The matter relating to proposal received from the Ministry of SJ&E on modification in the SC list of Odisha State-Proposal for deletion of the communities of Patratanti (Sl.No. 16), Bariki (Sl.No.3) and Kummari (Sl.No.49) from the list of Scheduled Castes of Odisha State has been discussed and considered. It was decided that before arriving any decision in the matter, the views of the Chief Secretary, Govt. of Odisha may be obtained by calling him in person before the Commission. The Commission will decide the matter accordingly. **(Action: SSW)**

The meeting ended with thanks to the Chair.
