## Agenda Item No.1: Action taken on the minutes of the Third meeting of the Commission held on13.12.2010.

## Agenda Item No.2: Confirmation of the minutes of the Fourth meeting of the Commission held on 27.12.2010.

#### Agenda Item No.5: Fixation of seniority on the basis of Rosters as per reservation orders.

The issue was discussed and it was decided by the Commission that in the first instance the comments of various Ministries may be obtained and the aspects of legal complication if any may also be examined and put up before the Commission. (Action: SSW)

Agenda Item No.6: Non-implementation the decision of the NCSC after agreeing to the decisions of NCSC in the two hearings and questioning the powers of NCSC by a subordinate body of NACIL later on.

The case of Smt. Deepa Kanchan for promotion to the post of General Manager in Air India was discussed with the CMD Shri Anil Jadhav and Director (Personnel) Shri Anoop Srivastava. The Hon'ble Chairman asked the CMD to examine the case of Smt. Deepa Kanchan and four other cases regarding promotion of Shri N.K.Saroa, Senior Flight Engineer, NACIL and Smt. Lalita Devi W/O Late Shri Rajender Kumar, ex-Helper (Engg.) IGIA regarding compassionate appointment, sexual harassment case of Smt. Usha,Senior Office Supdt., and Shri Meer Singh, General Secretary, All India Confederation of SC/ST Organization, Karol Bagh, New Delhi and unceremonious removal of Airhostess and explain the position to the Commission on 24.01.2011. Detailed minutes, however, shall be prepared by the SSW and APCR Wings from the concerned case files. (Action: SSW & APCR)
