MINUTES OF 32nd MEETING OF NATIONAL COMMISSION FOR SCHEDULED CASTES (NCSC) HELD ON 17.06.2013 AT 2.00 PM.

 $32^{\rm nd}$ Meeting of the National Commission for SCs (NCSC) was held on 17.06.2013 at 2.00 PM under Chairmanship of Dr. P. L. Punia, Chairman, NCSC in his office. List of participants is at **Annexure 1.**

2. After deliberations following decisions were taken:

2.1 Agenda No. 32.1: Confirmation of minutes of 31st meeting of the Commission held on 29.4.2013.

Decision: Minutes of the 31st Meeting held on 29.4.2013 were confirmed.

2.2 Agenda No. 32.2: Action taken on minutes of 31^{st} meeting of the Commission.

Decision: Action taken reports were noted.

2.3 Agenda No. 32.3: Open hearings done by NHRC

Decision: This issue was discussed in the last meeting of the Commission and it was decided that NCSC is already listening to the grievances of SCs. However, further gradual improvement in the process on NHRC pattern may be considered if feasible. Shri Raju Parmar, Hon'ble Member brought to the notice of the Commission that NHRC is holding public hearing on those issues which have already been taken up in Gujarat. It was decided that NHRC may be suitable informed giving reference of the minutes that these issues have already been taken up by the NCSC on 12.4.2012. (Action: APCR)

2.4 Agenda No. 32.4: Restoration of exchange of vacancies reserved for SC/ST.

Decision: It was informed that NCST has not agreed to interchange of vacancies between SC & ST & vice-versa. Commission decided that the existing rule position on the subject may be examined taking into consideration number of vacancies dereserved in order to make suitable recommendations to DoP&T. (Action: SSW)

2.5 Shortfall/Non filling of reserved posts by UPSC.

Decision: On receipt of requisite information from UPSC a hearing will be fixed. (Action: SSW)

Any other items with the permission of the chair.

- (i) Action may be taken to hold public hearing on 2.7.2013 at Bangalore for Exclusion of 4 Castes in the SC list. (Action: SSW)
- (ii) Chairman expressed unhappiness on the slow implementation of CMIS and desired that CMIS should be implemented fully at Headquarters and State Offices and all the receipts/petitions should be registered on the day of receipt. (Action: APCR, SSW and all the State Offices)
- (iii) Checklist should be prepared to monitor payment of [#]Scholarship/fee to SC students and to ascertain cases of Self Finance in private Medical and Engineering Institutes. (Action: ESDW)
- (iv) Two Committee Reports on Residential Schools and Review of Safeguards may be circulated to Members inviting their comments/views. (Action: Concerned Member Secretaries)
