(iv) All efforts will be made for speedy disposal and as far as possible a maximum of 3 hearings to be conducted in cases.

Decision Taken: After analysis the Report it was decided that the number of affected SC labourers in these cases can be mentioned. Some visits to Brick Kilns (in Bihar, Maharashtra & Madhya Pradesh). Suggestion of Hon'ble Member (RP) to include "district administration to ensure proper living conditions for the labourers" in the recommendation was agreed to. **(Action: ESDW)**

Action Taken: The Study on Labour Exploitation of Scheduled Castes population in the brick manufacturing sector effected SC workers has been revised after incorporating field visit reports from Bihar & Maharashtra, 10 more cases of Lucknow State Office have been incorporated.

MINUTES OF THE EMERGENCY MEETING OF NATIONAL COMMISSION FOR SCHEDULED CASTES HELD ON 02.11.2015 AT 12.30 PM.

Emergency Meeting of the National Commission for Scheduled Castes (NCSC) was held on 02.11.2015 under the Chairmanship of Dr. P. L. Punia, Hon'ble Chairman, NCSC. List of participants is at **Annexure 1.** The following Agenda items were taken up for discussion.

Agenda Item No. 1: Confirmation of minutes of the Sixth meeting of the Commission held on 21.07.2015.

Decision Taken: Minutes of the Sixth meeting of the Commission were approved unanimously.

Agenda Item No.2: Action Taken Notes on the minutes of the Sixth meeting of the Commission.

Decision Taken: Action Taken on decisions on the all items discussed in the Sixth meeting held on 21.07.2015 was noted and approved. Item No. 10 was specially discussed during the meeting held on 21.7.2015 discussed and following was outcome.

Hon'ble Members Shri Raju Parmar and Smt. P.M. Kamalamma confirmed that they had disposed cases as mentioned in ATR. However disposal at Hyderabad is by both Hon'ble Member (RP) & Hon'ble Member (PMK). Hon'ble Member (PMK) stated that she had disposed 225 cases in Bangalore also and that can be added.

"Chairman appreciated the disposal of cases undertaken by the Members and advised this tempo of disposal should be continued. Hon'ble Chairman, Vice-Chairman and Hon'ble Member (IS) will also take up cases in their respective States. More divisional review meetings like those held by Hon'ble Chairman & Hon'ble Member IS) should be held to expedite disposal of cases.

Agenda Item No.3:	Approval of the draft Annual Report 2014-15.

Decision Taken: Draft Annual Report was discussed. It was reported that minor corrections correct to language, spacing, graph type (for example in graphs 8.1, 8.2, 8.10 etc.) are being made.

In Chapter IX – Recommendations: 9.1.3 be deleted and points recommending, constitutional amendment for reservation in promotion, Bill on reservation in Services, All India Judicial Services consultation with NCSC on Planning, Legislation on SCSP on lines of Andhra Pradesh & Karnataka, National

Vigilance & Monitory Committee, expediting amendment to POA Act, Strengthening National Commission for Backward Classes may be added as per the revised draft put up on 2.11.2015. They will be placed in chapter wise recommendations also. The Annual Report with these amendments was approved & Hon'ble Chairman was authorized to approve final version. Necessary action for early translation & printing to be taken so that it may be submitted within this month. **(Action: Consultant/C.Cell/Genl. Admn.)**

Decision Taken: The reporting item was accepted and approved. **(Action: C.Cell/SSW)**

Agenda Item No.5:	Any other item with the permission of the chair.

(i) Revised Report on Study of Cases in National Commission for Scheduled Castes on Exploitation of Scheduled Castes Labour in the Brick Kiln Sector: After deliberation on the revised report, the Commission authorized the Chairman to finalize the revised Report, which can then be submitted as a separate report & also sent to Governors of the concerned States.. (Action: Consultant / C.Cell)

(ii) Study Report on the Effective Utilization of Funds under the Scheduled Castes Sub Plan: Data & input from some NGOs have also been called for and input from 1 NGO has been received & is being compiled. (Action: Consultant/ESDW /C.Cell)

(iii) **Engagement of staff on contract** – The Commission discussed the acute shortage of staff in the Headquarters & the State Offices and decided that efforts should be made to fill up the posts. Hon'ble Member (PMK) proposed for more DEO's to be taken on outsourced basis in States Offices & Hqrs. as the work load is increased till regular posts are filled. The same was approved on need basis especially for Chennai, Ahmedabad, Lucknow & Hqrs. where there are large number of cases. The expenditure is to be kept within sanctioned funds in OE. (Action: Admn./Genl.Admn.)

(iv) **Review of Jail** - The Hon'ble Vice-Chairman & Shri Ishwar Singh, Hon'ble Member pointed out that the authorities in Punjab & Haryana are reluctant to allow the Commission to visit Jails though review of Jails were carried out in some other States. It was decided that Jail Review / Visits should be conducted after obtaining data in questionnaire, including data on ladies prisoners. In view of the specific problem regarding Jail visit/review being faced in Punjab & Haryana, it was decided that a letter may be sent to Chief Ministers of Punjab & Haryana regarding the fact that Commission has the mandate to review working of Jails may be sent. (Action: Consultant)

(v) **Reopening of cases:** Hon'ble Vice-Chairman brought up case of Mrs. Premwati regarding compassionate appointment of 2nd son in BHEL & it was discussed. Detailed recommendations in that were issued in the case by Hon'ble Member (M. Sivanna) & Hon'ble Member (RP) and Action Taken Report has also been submitted by BHEL as per the legal advice that Compassionate appointment to 2 sons of same person is not as per rules. The complainant is insisting NCSC reopen her case for appointment of her second son. It was decided that since recommendations have been issued & ATR also received, NCSC has no role to place & the case may remain closed. As a policy such cases where recommendations are issued & ATRs on recommendation are also received may not be reopened. **(Action: SSW)**

(vi) **Hon'ble Member (PMK) brought out issue of Capital city of AP:** New Capital of Andhra Pradesh is established at Amaravati & the Govt. of Andhra Pradesh is acquiring the land for the same. The compensation against the land acquisition should be given equal to the patta land holders and assigned land holders. Issue to be examined & letter to be sent from Secretary to the Chief Secretary for the same. **(Action: Consultant /ESDW)**

(vii) **Hon'ble Member (PMK) brought up:** The Andhra Pradesh High Court has given a judgment that offence having the punishment of seven years will be bailed from the Police Station but this may not be applicable for the cases registered under SC/ST POA Act. It was decided that issue will be examined & letter to be sent from Secretary to Chief Secretary of the State. **(Action: Consultant / APCR)**

The meeting ended with thanks to the Chair.
